I understand:

- that this is a Christian Mission team and that I must conduct myself in a manner which reflects Christian Biblical principals at ALL times.
- That if I do not conduct myself in a manner which is conducive to the mission I may be asked to return home, and I will be required to pay the costs for an early return. This determination is strictly at the TEAM Directors discretion.
- that there is a mandatory team training day on June 6th in Marion, N.C. and unless otherwise arranged with the director, I am required to attend this meeting.
- That I am allowed two pieces of checked luggage at 50 pounds each. One piece of luggage is for my personal clothes and supplies. The other piece of luggage is to be a piece that I will leave in Kenya. All team members are to bring this piece of luggage to the team meeting in June. Team members will pack this piece of luggage with donated supplies and items for the children, pastors, and people we will be doing ministry with.
- That each team member is asked to collect donated items per the donation list and bring to the team meeting June 6th
- That the use of illegal drugs, the misuse of legal drugs, and alcohol consumption are not permitted on this trip and such use will result in my being required to return home at my own expense. Also, that it is illegal to transport drugs and may result in my arrest in a foreign country under horrendous conditions if I participate in this activity. In this event, Lydia Ministries International and their staff, volunteers, affiliates, and other team members are not responsible for me or my activity, nor for the outcome of such activity.
- That this is a "TEAM" event, and I am part of team. The team will be depending on me to carry my share of the team work.
- TEAM worship events are part of the team experience, and therefore my presence and participation are expected and required.
- I am required to have certain immunizations, one of them being the Yellow Fever immunization, and I must submit a copy of these to LMI. I also understand that I must carry with my person the OFFICIAL copy of my Yellow Fever record at all times.
- That it is illegal to carry a weapon on board of an aircraft unless it is approved by the airline (such as for U.S. Air Marshalls), these would include items such as scissors, sharp instruments, bullets, guns, knives, etc. and if I choose to carry and illegal weapon aboard, that I may cause harm to others and may be arrested and detained in either the US or a foreign country.
- That travel can be adventuresome, fun, spiritual, educational, and exciting. It can also be dangerous. I understand that any kind of travel means taking a risk. I take responsibility for my own life, my own safety, my own health, my own well-being and will not hold Lydia Ministries International (LMI) responsible for any harm caused by myself or others. These would include, but are not limited to accidents, acts of terrorism, acts of aggression, or acts of God.
- I am responsible for my travel to and from the Asheville Airport. If I do not arrive on time for my flight, I may have to forfeit my trip. In this event, the cost is not refundable to me. It is my obligation and responsibility to arrive no later than two hours in advance of the scheduled flight time.
- team debriefings, both daily and the scheduled debriefing in October (unless an absence has been pre-arranged with the director in writing) are mandatory. We are a "TEAM" and this is a team event/meeting.
- that this list is not the extent of my obligations as a TEAM KENYA 2009 member, and that I will receive a training manual which also contains further codes of conduct, safety measures, cultural awareness issues, dress codes, etc. and I agree to abide by these in order to have a successful team event.
- that the deposit is due May 15th of 1/3 the total cost of the trip, unless otherwise agreed upon with the director.
- I will be rooming with or more other TEAM members and will treat them and their belongings with respect.
- TEAM KENYA 2009 represents Lydia Ministries International and while on this mission I will not promote another agenda, which may be counter to the mission/ministry of LMI, unless first agreed upon with the director.
- I understand that photos taken on this mission trip reflect on the entire team and I agree not to post, publish, or disseminate photos of a derogatory or questionable nature of team events or team members. And, for this purpose, photos taken during the TEAM KENYA trip are the property of Lydia Ministries International. (If you have questions about this please ask. This is not meant to take away your freedom of speech or of recording your trip, it is meant to protect the mission and ministry and to protect team members. If you post something or publish something that may be derogatory to LMI or TEAM K, then the pictures belong to LMI and we can require that they be removed from the internet, this includes videos. If you think this is a strange or unreasonable request, please understand that many international ministries have the same clause.)
- That due to the nature of mission travel, team members may share conversations that are considered to be confidential, even if that is not stated in advance, and therefore I will be careful not to divulge confidences which have been shared with me.
- That I am representing not only Lydia Ministries International, but my home country, my home church, and most importantly -
- God. I will conduct myself with this in mind.

- That while this will be an exciting and adventuresome journey, people are people and even Christians have bad moments, and bad days. I will respect the feelings of my team members and leaders, and work for unity and a cohesive team, allowing my team members to work through issues they may be experiencing with grace, respect, compassion, Christian fellowship, and understanding. I understand that I can go to any team leader if I have a problem or am experiencing any kind of conflict and can expect to be heard, respected, and confidential treatment. I also recognize that team leaders are a part of a team and will work together through whatever conflicts arise. Therefore, what I share with a team leader, may be shared with other team leaders, including the director. This is so they may work together as a team to minister and serve as a cohesive and unified leadership unit. Therefore, I recognize that while we may be of one body, we may have differing thoughts and opinions within that body. We have each had different experiences and may come from a variety of cultures. Because of this, I will be sensitive to the rest of my team members and recognize that we are all part of this team because God has called us here together. Each team member brings his/her own gifts and graces and skills and each one is necessary to accomplish what God's plan is.
- That the early bird rate is only valid until June 15 unless otherwise stated by the director. This rate is \$2950.00 for the 15-16 day trip, and \$3,500.00 for the extended trip. In addition, if I choose to depart on September 7th with the leadership team, I may be required to pay an additional \$50.00 to cover my room, board, and additional ground transportation. (This does not apply to Leadership Team Members). After June 15th, the 15-16 day rate is \$3,500.00 for the 9th-23rd, and \$4,000.00 for the extended trip.
- I understand that the Medical and Liability release form MUST be notarized by a legal notary public and returned with the Application, Skills Assessment form and my deposit by May 15th. (Unless other arrangements have been made with the director.)

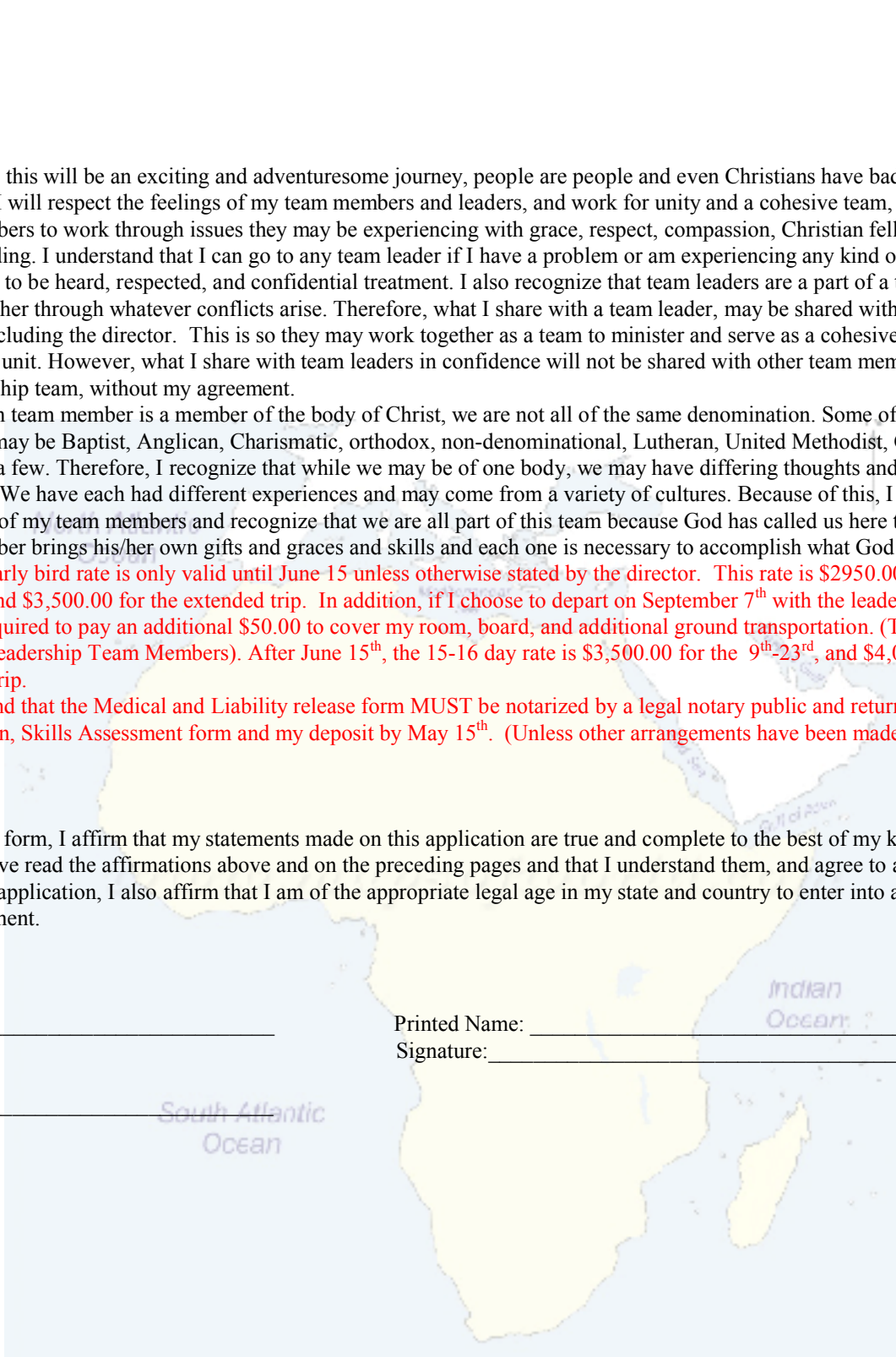

Dear TEAM KENYA 2009 Member,

I can not begin to tell you how excited I am about our upcoming departure! I can assure you that I have been working diligently, along with the team leaders to ensure that we will have a journey of a lifetime. I know that most of you are working to raise your funds, and I just want to encourage you not to become disheartened, but also not to become complacent. If you do your part, in prayer and in reaching out and letting people know that you are going on a mission trip, God will certainly do His part! (Thanks Sondra for reminding me of this!)

I also want to encourage each one of you to be collecting donations and to bring those along with a suitcase that you can leave in Kenya to the June 6th meeting. Remember, the team meeting is mandatory (don't you just hate that word!) in order for us to make sure that everyone has their passports, visas, immunizations, health insurance, and other paperwork in order. Please be sure to bring all of these to the June 6th meeting. This means if you have not yet applied for your passport or visa **you will need to do so immediately.**

In addition, I encourage you to contact your area health department to find out where you will have to go to get your immunizations. There are quite a number of them if you have not traveled outside of the USA recently. Do not wait until the last minute. Some of these require multiple shots (ouch) with time in-between. Please, try to have these all completed before August 1st. You will be glad you did!

Remember, if you collect financial donations the donor needs to write on the check if the donation is for your trip (so they will put your name at the bottom of the check). However, the check or money order needs to be made out to: Lydia Ministries International in order for it to be tax deductible. In addition, if they want to give a donation to go towards the mission and ministry of the trip, then they need to also indicate this on the check or money order. We will send out receipts in order for them to be able to count it off on their annual taxes. Furthermore, when you collect material donations (such as pens, pencils, etc.) please note who the donation is from, and an address in order for LMI to be able to send a receipt. Also, we need the value of their donation in order to send a receipt.

To Whom It May Concern:

In September, TEAM KENYA 2009 will travel to Kenya with a team of 15-20 volunteers to renovate a children's center in Kibera/Muthare, the world's second largest slum area. This will include cleaning, painting, and some much-needed remodeling. The children who attend the center/school are orphaned due to the AIDS epidemic and are living on the streets of the slum; some have been fortunate enough to have been taken in by families living in the slums. In a 2.2 square mile area, there are over 100,000 orphans; 80% are orphaned due to AIDS; and half of the 80% are HIV-positive (40,000 children). I know we cannot minister to all of them, but it is our team's hope that we will also be able to take much-needed school supplies and some basic clothing items for the children at the center. Many of these children are running barefoot through the streets, putting themselves at great health risk for infections from parasites or simple cuts. Most go for days without food, and have never known the taste of clean water.

In addition, part of the team will build a 4000 sq foot multipurpose building to serve as church/school in Namanga that members of the Maasai tribe desperately need, with two rooms to provide a home to the pastor who currently walks 7 miles daily to get to the church area. Maasai elders have given ten acres of land to build the church on, and the entire Maasai tribe will help with the building project. The children are presently meeting outside under the trees for school and are in danger from lion attacks.

Would you please consider giving supplies to this worthwhile cause and/or posting this at your church or place of work. We are accepting donations of toothpaste, toothbrushes, new children's underwear, new or gently used children's shoes (croc's and slip-on sneakers), #2 pencils, cap erasers, pens, 24-pack crayons, plastic pencil sharpeners, packs of notebook paper, 70-page spiral bound notebooks, children's vitamins; powdered infant formula, and over-the-counter medications (generic pain relievers for both adults and children, antibiotic cream or ointments, first aid supplies, Monistat or its generic equivalent, miconazole), dark purple 50/50 t-shirts in children and youth sizes for the school uniform shirts, dark navy shorts in boy's sizes and dark navy jumpers or skirts in cotton for girls, dark navy or dark purple knee socks, or white knee socks for girls.

If you would like to join team Kenya 2009, or know of someone who might, early registration deadline is May 15th. The cost of this trip is about half of what most mission trips of this duration and quality, to make the trip available to more people and get the job done.
